#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of Cascade Medical Center from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2016, 2015 and 2014, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll accuracy of amounts paid to employees
- Patient accounts receivable credit balances – appropriate activity and transactions
- Pharmacy physical inventory, adjustment monitoring, and package receipt verification

#### Financial

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from the Cascade Medical Center.

## INFORMATION ABOUT THE DISTRICT

Chelan County Public Hospital District No. 1 owns and operates Cascade Medical Center, a 12-bed acute care hospital and a Medicare-certified rural health clinic. The District provides healthcare service to patients in the Leavenworth area of Chelan County. Services provided include acute care, emergency room care, a physician's clinic and an ambulance service.

An elected, five-member Board of Commissioners governs the District. The Board appoints an Administrator to oversee the District's daily operations as well as its 150 full- and part-time employees. The District operated on annual revenues of approximately \$14.8 million in 2014, \$14.7 million in 2015 and \$15.9 million in 2016.
