AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated February 15, 2018, related to procurement. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Snohomish from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cost allocation to restricted funds
- Public works and purchasing bid law system review
- Credit card policies and procedures
- Backup and recovery for City's IT systems
- Citizen concern over procurement of solid waste services
- Citizen concern over use of City property and resources
- Citizen concern over leasing City property

INFORMATION ABOUT THE CITY

The City of Snohomish was established in 1890 and currently serves approximately 10,010 Snohomish citizens. The City provides services including parks and street maintenance, planning and development, water, sewer, storm water and solid waste utilities, law enforcement services and general administrative and financial services.

An elected, seven-member Council governs the City. The Council selects one of its members to serve as Mayor. In addition, the Council appoints management to oversee the City's daily operations as well as its 50 full-time employees. For fiscal year 2016, the City had total expenditures of \$22.7 million.
