## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the Pullman Regional Hospital from January 1, 2015 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2015 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Self-insurance – health and welfare and unemployment
- Procurement – public works, prevailing wages, professional services and change orders
- Physician subsidy agreements – recruitment to a hospital's geographic area or to retain a physician in the area.
- Patient billing/receivables – contractual adjustments

## INFORMATION ABOUT THE DISTRICT

Whitman County Public Hospital District No. 1A, doing business as Pullman Regional Hospital, operates a 25-bed critical access hospital in Pullman. The District provides medical, surgical, labor and delivery, nursery care, 24-hour emergency, laboratory, radiology, physical therapy, cardiac rehabilitation and physician services.

An elected, seven-member Board of Commissioners governs the District. The Board appoints management to oversee the District's daily operations as well as its 466 employees. In fiscal years 2015 and 2016, the District operated on budgets of approximately \$61 million and \$64 million, respectively.
