AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Lummi Nation School from September 1, 2014 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ending August 31, 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Basic education student enrollment reporting.
- Special education student enrollment reporting.
- Certificated staff mix credits and years of experience reporting.
- Transportation documentation to support ridership counts.
- Payroll (trend analysis)
- General revenues and expenditures (trend analysis)

INFORMATION ABOUT THE DISTRICT

Lummi Nation Tribal School No. 903 opened in September 2014 as one of the Washington State Tribal Compact Schools, located in Whatcom County. For fiscal year 2015, the Lummi Nation Tribal School served approximately 281 students in grades K-12. The Lummi Nation Tribal Schools education campus offers one elementary school, one middle school, and one high school. The school received approximately 2.6 million in direct state funding for fiscal year 2015. As a sovereign nation, the Lummi Indian Business Council has the ultimate control over the educational needs of the students attending the Lummi Nation Tribal School.
