AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Authority operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Central Skagit Medic One from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements and credit card activity
- Safeguarding of controlled substances

INFORMATION ABOUT THE AUTHORITY

Central Valley Ambulance Authority, which operates as Central Skagit Medic One, was created by Skagit County Ordinance as a separate legal entity on July 1, 2009. The Authority remains a component unit of Skagit County and the Skagit County Commissioners retain executive power including approving the Authority's bylaws, budget, and appointing members of the Authority's governing board.

The Authority's Board of Representatives is comprised of seven members representing the cities of Mount Vernon, Burlington, Sedro-Woolley, two rural fire districts, the Skagit County Fire Commissioners, and one at large position. The Board along with approximately 40 employees provide emergency medical and related services to citizens in the Central Skagit Valley. For fiscal year 2017, total operating expenditures for the Authority were \$5.5 million.
