#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of Port of Quincy from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition and fiscal sustainability
- Golf course cash receipting
- Leases cash receipting and compliance with leasing contracts

#### INFORMATION ABOUT THE PORT

The Port of Quincy was formed in 1958 and is located in Grant County. The Port operates five Industrial Development Parks as well as an Intermodal Park to promote the existing industrial facilities and develop new facilities to attract businesses to the area. The Port also operates the Quincy Municipal Airport, the Colockum Ridge Golf Course, Bishop Recreation Area (BRA) and the Quincy Valley Business & Conference Center.

An elected, three-member Board of Commissioners governs the Port. The Board appoints an Executive Assistant who is also the clerk of the Board, an Assistant Executive Assistant/Human Resources Director and a Comptroller. For fiscal years 2016 and 2017, the Port had annual operating revenues of about \$1.6 million.
