## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of Port of Ephrata from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance – unemployment compensation
- Procurement – public works, prevailing wages and purchases
- Leasing activity – compliance with lease agreement requirements and receipting of lease payments
- Surplus – selling and disposal of District vehicles and equipment

## INFORMATION ABOUT THE PORT

The Port of Ephrata, located in Grant County in the City of Ephrata, was established in 1965 to operate the city airfield. The Port provides general aviation services, including runway services and hangar space for private aircraft and also provides rentals of nearby industrial buildings for businesses.

An elected, three-member Board of Commissioners governs the Port. The Board appoints a Port Manager to oversee daily operations and its two other full-time employees and one part-time employee. For fiscal years 2016 and 2017, the Port operated on annual budgets of about \$850,000 and \$1.2 million, respectively.
