AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Bellingham-Whatcom Public Facilities District from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Disbursements
- Debt covenant compliance
- Financial condition and fiscal sustainability
- Open public meeting minutes

INFORMATION ABOUT THE DISTRICT

The Bellingham-Whatcom Public Facilities District was formed in July 2002 as a joint effort between the City of Bellingham and Whatcom County. The District's mission is to fund a Regional Center and Cultural District located in downtown Bellingham that will create economic growth and lay a foundation for further public and private investment in the community. The District owns the Mount Baker Theatre and the Whatcom Museum's Lightcatcher Building.

The District is governed by a four-member Board of Directors and an inter-local agreement between the District and the City of Bellingham. It is managed by two part-time employees with operational support from the city and private service contracts. Total operating expenditures in 2015, 2016 and 2017 were \$1,563,364, \$1,221,969 and \$1,345,226 respectively.
