AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Lake Forest Park Water District from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Small and attractive assets tracking and disposal
- Compliance with bid law and prevailing wage statutes

INFORMATION ABOUT THE DISTRICT

The Lake Forest Park Water District, organized in 1948, is located in the city of Lake Forest Park, King County. The District serves approximately 900 combined residential and commercial connections including Lake Forest Park Town Center and Lake Forest Park Elementary with clean, chemical free well water from eight artesian wells and five deep wells in two well fields. The District is bordered by three other water utilities: Northshore Utility District, North City Water District and Seattle Public Utilities.

An elected, three-member Board of Commissioners governs the District. The Board appoints a General Manager to supervise daily operations. The District's operations are funded by revenue from water services, water connection fees and interest earnings. Annual revenue is approximately \$670,000.
