AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Port of Port Angeles from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cash-receipting and fuel inventory at John Wayne Marina
- Employee reimbursements
- Payroll – overtime
- Port airport and real estate leases
- Fee waivers and rental credits
- Policies regarding wireless communications and information subject to public records requests

INFORMATION ABOUT THE PORT

The Port of Port Angeles is a small classified port district located in Clallam County. The Port provides an array of services including marine terminals, log yard, marinas, airports, industrial parks and rental properties.

An elected, three-member Board of Port Commissioners governs the Port. The Board appoints an Executive Director to manage the Port's daily operations and the staff of approximately 50 employees. For 2017, the Port operated on annual operating budget of approximately \$10.8 million.
