#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Housing Authority operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of the Housing Authority of the City of Renton from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Housing Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billing and receipting of rental revenues
- Procurement public works projects
- Self-insurance for workers compensation

#### **Financial**

#### Federal grant programs

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Housing Authority's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report.

## INFORMATION ABOUT THE HOUSING AUTHORITY

The Housing Authority of the City of Renton administers housing programs for low-income families and the elderly. The Housing Authority accomplishes this through construction, financing and operating subsidies from the U.S. Department of Housing and Urban Development (HUD).

An appointed, five-member Board of Commissioners governs the Housing Authority. The Mayor of the city of Renton appoints the Commissioners. One of the Commissioners is a Resident Commissioner; each Commissioner serves a five-year term. In addition, the Board appoints an Executive Director to oversee the Housing Authority's daily operations as well as its 50 employees. For fiscal year 2017, the Housing Authority had operating expenses of \$17.7 million.
