## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the City of Shoreline from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Restricted funds (transportation impact fees) – compliance with state statute and City policy
- Third part cash receipting – compliance with legal and contractual requirements

## INFORMATION ABOUT THE CITY

The City of Shoreline, incorporated in November 1995, serves a population of 54,500 citizens in King County. The City provides community and economic development, public works, and parks and recreational services. It contracts with King County for police services. Separate agencies provide fire protection and water services.

An elected, seven-member Council governs the City. The Council selects one of its Members to serve as Mayor for a two-year term. The Council appoints a Manager to oversee the City's daily operations as well as its 169 full-time employees. For fiscal year 2017, the City operated on an annual budget of approximately \$91.5 million.
