#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of the City of Granite Falls from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement over purchases and public works projects
- Monitoring and use of restricted funds
- General disbursements and credit card transactions
- Selected Information Technology (IT) policies, procedures, practices and controls protecting financial systems, IT systems and data
- Financial condition and fiscal sustainability
- Open Public Meetings minutes

The City of Granite Falls was incorporated in 1903 and currently serves approximately 3,485 Snohomish County citizens. The City provides an array of services including public safety, utility services, street maintenance and parks and recreation to its residents.

An elected, five-member Council and an appointed City Manager govern the City. The City Manager appoints management with the City Council's approval, to oversee the City's daily operations as well as its nine full-time employees. For 2016, the City operated on annual budget of \$7,133,358 and for 2017, the annual budget was \$5,167,754.
