#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of the City of Chewelah from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance unemployment compensation
- Procurement (bidding) public works and prevailing wages
- Billings/receivables utility billings and cash receipting through software system
- Police Department custody of evidence (property room) and small and attractive assets

## INFORMATION ABOUT THE CITY

The City of Chewelah was incorporated in 1903 and serves approximately 2,650 residents in Stevens County. It provides an array of services including public safety, fire protection, street improvement, water, sewer, electric, garbage, parks and recreation, cemetery and general administrative services. The City also operates a museum and an airport.

An elected, seven-member Council with a separately elected Mayor governs the City. The Mayor appoints a City Administrator to oversee the City's daily operations. For fiscal year 2016 and 2017 the City operated on an annual budget of approximately \$6.6 million and \$6.6 million, respectively.
