#### AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and the Board of Commissioners in a letter dated October 31, 2018 related to procurement requirements. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of Benton County Fire Protection District No. 6 from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll gross wage recalculation
- Procurement architectural and engineering services and public works
- General disbursements

#### **INFORMATION ABOUT THE DISTRICT**

Benton County Fire Protection District No. 6 was formed in 1982 to provide fire protection and fire suppression services and Emergency Medical services for citizens of Benton County. The District serves the southern area of Benton County.

An elected, three-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as its volunteers. The District is funded primarily from property taxes and emergency medical services. In 2015, 2016 and 2017, the District's revenues were \$515,000, \$872,000 and \$940,000, respectively.
