## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of Odessa Memorial Healthcare Center from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Pharmacy controls – inventory and tracking
- Self-insurance – unemployment compensation
- Payroll – employee bonus compensation
- General disbursements – employee appreciation program
- Procurement – awarding of bids through purchasing cooperatives

## INFORMATION ABOUT THE DISTRICT

Lincoln County Public Hospital District No. 1, doing business as Odessa Memorial Healthcare Center, was formed in 1947. The District owns and operates Odessa Memorial Healthcare Center, a licensed 25-bed critical access hospital, as well as the Odessa Memorial Clinic and Quail Court, a 12-unit assisted living complex. The District provides inpatient, outpatient, skilled nursing, assisted living, medical clinic and emergency care services for the residents of Lincoln County.

An elected, five-member Board of Commissioners governs the District. The Board appoints an Administrator to oversee the District's daily operations as well as its 85-88 employees. For fiscal years 2016 and 2017, the District operated on annual revenues of approximately \$7.5 million and \$8.5 million, respectively.
