## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of Klickitat Valley Health from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll recalculation of gross wages
- Patient billing adjustments
- Cash receipting cash counts
- Accounts payable transactions general disbursements and credit cards
- Financial condition and fiscal sustainability
- Tracking and monitoring of pharmaceutical inventory
- IT security practices and controls for key software applications
- Self-insurance for unemployment and workers compensation

# **INFORMATION ABOUT THE DISTRICT**

Klickitat County Public Hospital District No. 1, doing business as Klickitat Valley Health, owns and operates a 25-bed acute care hospital, a Family Practice Rural Health Clinic, and a home health and hospice agency. The District provides acute care and clinical services to patients in the Goldendale area. Services include inpatient medical, surgical, 24-hour emergency, laboratory, radiology, physical therapy, home health, and physician clinics. Medical staff includes specialists in emergency medicine, family practice, general surgery, radiology and pathology.

The District is governed by an elected, five-member Board of Commissioners. The Board appoints a Chief Executive Officer that manages daily operations. Management oversees the District's approximately 200 employees. The District derives most of its revenue (about 77 percent) from outpatient services. The District's budgeted operating expenses were \$22.2 million in 2016 and \$24.7 million in 2017.
