#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Hydropower operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of the Columbia Basin Hydropower from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Hydropower's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements approval and supporting documentation
- Credit card purchases
- Fuel card purchases
- Payroll overtime and gross pay increases

### INFORMATION ABOUT THE HYDROPOWER

Columbia Basin Hydropower was established by East, South and Quincy-Columbia Basin Irrigation Districts to operate hydroelectric generating facilities jointly developed by the Districts. The Districts share equal ownership of the Hydropower. The Hydropower operates and maintains Main Canal, Summer Falls, Eltopia Branch Canal 4.6, Potholes East Canal 66 and Russell D. Smith (P.E.C. 22.7) power plants within the Columbia River Basin Project.

The Hydropower is governed by a six-member Board of Directors. Each of the Irrigation Districts appoint two representatives, each serving a one-year term. The Hydropower employs about 20 full-time and two seasonal staff. Hydropower operating revenues totaled \$12.4 million and \$14.6 million in 2016 and 2017, respectively.
