AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Orcas Island Fire & Rescue from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- General disbursements including credit cards and employee reimbursements
- Third-party billing and receipting

INFORMATION ABOUT THE DISTRICT

San Juan County Fire Protection District No. 2 is located on Orcas Island, which is a part of San Juan County. The Fire District goes by the name of "Orcas Island Fire and Rescue". The District maintains seven different fire stations throughout Orcas Island and is currently staffed by: four career/full-time Fire Officer Paramedics, four career/full-time Fire Officer EMT's, two administrative assistants, one Director of Administrative Services, the fire chief, and over 60 volunteer firefighters, EMT's and First Responders. The District provides firefighting and emergency medical services to the Orcas Island residents. The main source of revenues comes from property taxes. The District does not have a separate EMS levy and is currently billing for providing medical aid and ambulance transport services.

A five member Board of Commissioners is in charge of district governance with day-to-day operations overseen by the fire chief. For the years under audit, the District operated on annual operations budgets of approximately \$2 million in 2016 and \$2 million in 2017.
