AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

However, as noted under the Related Reports – Special Investigations section of this report, certain matters were examined and reported as part of a separate engagement.

About the audit

This report contains the results of our independent accountability audit of the South Kitsap Fire and Rescue from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance unemployment
- Credit cards and fuel card disbursements
- Cash receipting
- Procurement sole source exceptions

We also noted certain matters that we communicated to District management in a letter, dated January 2019, relating to a loss of public funds from inadequate controls over purchases and use of benefits received from vendors. We appreciate the District's commitment to resolving those matters.

INFORMATION ABOUT THE DISTRICT

Kitsap County Fire Protection District No. 7, doing business as South Kitsap Fire and Rescue, was established in 1946 to provide fire protection service to Kitsap County. The District covers approximately 118 square miles, serves more than 72,000 citizens and generated about \$16.6 million in revenues in 2017. In addition to fire protection, the District offers fire prevention programs, Basic Live Saving and Advanced Life Saving emergency medical services out of 12 fire stations.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Fire Chief to oversee the District's daily operations as well as about 85 employees and 50 volunteers.
