AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Lake Stevens from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Use of restricted funds building/land use permit revenues
- Payroll disbursements, leave accruals and activity
- Cash receipting City Hall
- Accounts payable general disbursements including credit cards
- Procurement piggybacking
- Petty cash review of replenishments
- Financial condition and fiscal sustainability

INFORMATION ABOUT THE CITY

The City of Lake Stevens has a population of approximately 32,800 citizens and encompasses approximately nine square miles in Snohomish County.

A council-mayor form of government administers the City with seven elected Council Members and a separately elected Mayor. The City has 85 employees providing police, planning and zoning, park maintenance, street maintenance and general government services. The City's expenditures for 2016 and 2017 were \$13.1 million and \$15.2 million, respectively.
