AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

However, as noted under the Related Reports – Special Investigations section of this report, certain matters were examined and reported as part of a separate engagement.

About the audit

This report contains the results of our independent accountability audit of the City of Issaquah from January 1, 2017 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll gained an understanding of pay increases and reviewed payments to ensure pay was properly approved, supported, and calculated
- Agreements and contracts reviewed a development agreement to ensure timely billing and compliance with terms of the agreement

Financial

Our opinion on the City's financial statements is provided in a separate report, which includes the City's financial statements. That report is available on our website, <u>http://portal.sao.wa.gov/ReportSearch</u>.

That report includes a finding for a material weakness in internal controls over financial reporting regarding the City's controls over financial statement preparation.

Special investigations

We noted certain matters that we communicated to City management in a letter dated January 17, 2019, relating to misappropriation of public funds at the Community Center. We appreciate the City's commitment to resolving those matters.

INFORMATION ABOUT THE CITY

The City of Issaquah serves approximately 37,110 citizens in east King County. The City provides provide services such as water, sewer and storm water utilities, police, development services, economic development, parks and recreation, support services, Municipal Court and cemetery.

The City has an elected Mayor as well as seven elected council members. The Mayor appoints, and Council approves, the City Administrator who oversees the City's daily operations and approximately 272 budgeted full- and part-time employees. For fiscal year 2017, the City operated on an annual general fund budget of approximately \$43.3 million and a capital projects budget of approximately \$43.7 million.
