AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Commissioners in a letter dated January 31, 2019, related to purchasing through cooperatives and internal controls over payroll. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Lewis County Fire Protection District No. 6 from January 1, 2015 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017, 2016 and 2015, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement – cooperative purchases
- Self-Insurance for unemployment compensation
- Payroll – gross wages
- Open public meetings – documentation of minutes and executive sessions

INFORMATION ABOUT THE DISTRICT

Lewis County Fire Protection District No. 6 was formed in 1956. The District provides fire prevention and suppression services, emergency medical aid and protection of life and property to residents living within the service boundaries.

An elected, three-member Board of Commissioners governs the District. The District has a full-time Fire Chief, one part-time Assistant Chief, one Training Officer, three Shift Leads, and one Board Secretary. Approximately 30 volunteers and 7 career FTEs provide general fire and emergency medical services to the area surrounding the city of Chehalis. The District operates on a \$1.6 million annual budget with the primary source of revenue coming from property taxes.
