#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of Warden School District No. 146-161 from September 1, 2016 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body fundraising activities
- Payroll gross wages
- General disbursements and credit card activity
- Student enrollment reporting

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. ## INFORMATION ABOUT THE DISTRICT

Warden School District No. 146-161 provides public school services to students in kindergarten through 12th grade in Grant County. The District serves approximately 960 students. The District has one elementary school building. Its middle school and high school share another building. The District provides basic and supplementary education programs and services for hearing impaired, handicapped, special education and special education pre-school students. In addition, the District provides breakfast and lunch programs, Associated Student Body and transportation services.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's day-to-day operations as well as its 140 full- and part-time employees. The District operates on an annual budget of approximately \$12 million.
