AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to City management and Mayor and City Council in a letter dated February 21, 2019, related to cost allocation and procurement. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Brier from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cost allocation plan – equitable distribution of indirect costs
- Procurement – purchases
- Use of restricted funds – real estate excise taxes (REET), emergency medical services taxes, and zoning and plan check fees
- Selected IT security policies, procedures, practices, and controls protection financial systems, IT systems, and data
- Financial condition and fiscal sustainability

INFORMATION ABOUT THE CITY

The City of Brier was incorporated in 1965 and currently serves approximately 6,600 residents in Snohomish County.

The City is administered by a mayor-council form of government with seven elected Council Members and an independently elected Mayor. The City's 18 full-time employees provide services including sewer, police, planning, public works and parks and recreation. The City contracts with Snohomish County Regional Fire Authority for fire services and participates in a joint venture partnership with Snohomish County and other local governments for emergency services. The City's revenue for 2016 was approximately \$6 million and for 2017, it was approximately \$6.4 million.
