#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Directors in a letter dated March 26, 2019, related to purchases through cooperatives. We appreciate the District's commitment to resolving those matters.

#### About the audit

This report contains the results of our independent accountability audit of Olympia School District No. 111 from September 1, 2017 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body activities at Capital High School, Olympia High School and Washington Middle Schools – fundraisers and student store
- Tracking and monitoring of theft sensitive assets, such as computers, tools and equipment
- Procurement purchases through cooperatives
- Payroll gross wages and additional time compensation
- Financial condition and fiscal sustainability
- Open public meetings—documentation of minutes and executive sessions

#### **Financial**

Our opinion on the District's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the District's financial statements. We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. #### Performance audits

Initiative 900, approved by voters in 2005, gives the State Auditor's Office the authority to conduct independent performance audits of state and local government entities. ### INFORMATION ABOUT THE DISTRICT

Olympia School District No. 111 serves approximately 9,900 students in the city of Olympia and the northwest part of Thurston County. The District's main objective is to provide public school services to students in kindergarten through 12th grade. The District has 19 schools: 11 elementary schools, four middle schools, three high schools, including the Avanti alternative high school, and one K-12 learning academy offering Montessori, on-line and parent partnership programs. The District is also a member of the New Market Vocational Skills Center, a cooperative of nine school districts that focuses on vocational education. The District offers a wide variety of supplemental programs and learning opportunities such as Special Education, Gifted Education, English as a second language and Early Childhood programs.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 1,500 employees. For the 2017-2018 school year, the District operated on an annual General Fund budget of \$123.5 million.
