AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of Longview School District No. 122 from September 1, 2016 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body (ASB) activities at High Schools fundraisers and cash receipting
- Cash receipting for facility rentals and daycare services including voids and adjustments
- Cash receipting at Mark Morris High School timeliness and completeness of deposits, adjustments
- Payroll gross wages, including overload and additional time, responsibility, and incentive (TRI) pay, and leave accruals
- Self-insurance for vision
- Accounts payable general disbursements and credit cards
- Financial condition and fiscal sustainability

INFORMATION ABOUT THE DISTRICT

Longview School District No. 122 serves approximately 6,500 students from kindergarten through 12th grade in the city of Longview and portions of Cowlitz County. The District is composed of 15 schools including a pre-kindergarten learning center, eight elementary schools, three middle schools and three high schools. The District also operates an alternative learning program and a dropout reengagement program.

An elected, five-member Board of Directors has oversight responsibility for the District, appointing management, setting the budget and holding other fiscal responsibilities. For fiscal years ended 2017 and 2018, total revenues were \$79.7 million and \$85.4 million, respectively.
