AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to the District management and Board of Directors in a letter dated April 25, 2019, related to internal controls over Associated Student Body (ASB) activities. We appreciate the District's commitment to resolving those matters.

Additionally, during the audit certain matters came to our attention that are currently under investigation.

About the audit

This report contains the results of our independent accountability audit of Sequim School District No. 323 from September 1, 2016 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body activities at Sequim High School and Sequim Middle School – fundraisers, expenditures, and events
- Financial condition and fiscal sustainability
- Payroll gross wages
- Self-insurance health and welfare

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE DISTRICT

Sequim School District No. 323 provides a full range of school programs and services to approximately 2,800 students in kindergarten through 12th grade. Specific services offered include basic elementary, middle school, high school, vocational education, alternative learning, pupil transportation, food services and special education.

An elected, five-member Board of Directors governs the District. Board Members serve staggered, four-year terms. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 280 employees. The District operated on annual budgets for fiscal year 2018 and 2017 of approximately \$36 million and \$33 million, respectively.
