AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to District management and Board of Directors in a letter dated April 8, 2019, related to payroll. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of Orcas Island School District No. 137 from September 1, 2016 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Student enrollment apportionment reporting
- Cash receipting – timeliness and completeness of deposits, contract compliance with third party vendors
- Payroll – wages, leave balances and accruals, benefit and retirement payments
- Theft sensitive assets – ordering, receiving and tracking of inventory
- Donations – receiving payments and allowable uses
- Procurement – public works and purchases

INFORMATION ABOUT THE DISTRICT

Orcas Island School District No. 137 provides educational services to approximately 804 students in kindergarten through 12th grade in San Juan County.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its approximately 50 certificated and 50 classified employees. The District operated on expenditures of \$10.7 million for the 2016-2017 school year and \$12.6 million for the 2017-2018 school year.
