AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of North Beach School District No. 64 from September 1, 2016 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body activities at North Beach Junior/Senior High School – documentation of student council minutes, fundraisers, and expenditures
- Payroll – gross wages and garnished wages
- Self-insurance assessment
- Accounts payable – general disbursements
- Financial condition and fiscal sustainability
- Open public meetings – documentation of minutes and executive sessions

Financial

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the District's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. Performance audits

Initiative 900, approved by voters in 2005, gives the State Auditor's Office the authority to conduct independent performance audits of state and local government entities. INFORMATION ABOUT THE DISTRICT

North Beach School District No. 64 provides educational services to approximately 672 students in pre-school through 12th grade in Grays Harbor County. The District has four schools: two elementary, one junior high and one high school.

The District's five-member Board of Directors is the primary policy-making body, exercising budgetary and financial control for the District. Members are elected to staggered, four-year terms. The Superintendents and staff administer day-to-day operations and carry out decisions made by the Board. The District operates on a \$10.5 million annual budget. The District has 42 certificated teachers, 7 administrators, and 59 classified staff.
