AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Fidalgo Pool and Fitness Center District from January 1, 2016 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2018, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance for unemployment compensation
- Cash receipting – timeliness and completeness of deposits, voids and adjustments
- Accounts payable – general disbursements, credit cards and employee reimbursements

INFORMATION ABOUT THE DISTRICT

Fidalgo Pool and Fitness Center District is located in Anacortes and operates a pool and fitness facility for use by approximately 20,700 residents of Fidalgo Island in Skagit County.

An elected, five-member Board of Commissioners governs the District. Board Members serve staggered, four-year terms. The Board appoints an Executive Director to oversee the District's daily operations as well as its nine full-time employees. The District is funded primarily through property taxes and facility user-fees. For fiscal years 2016, 2017 and 2018, the District received revenue of approximately \$1,098,824, \$1,186,203 and \$1,373,707, respectively.
