## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of Central Valley School District No. 356 from September 1, 2017 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- School lunch revenue cash receipting
- Tracking and monitoring of theft-sensitive assets, such as musical instruments, laptops, computers, printers and cameras, at University and Central Valley high schools, Liberty Creek Elementary School and Horizon Middle School
- Compliance with new bond issuance requirements and allowable uses of bond proceeds
- Procurement – public works, architectural and engineering services
- Student basic enrollment reporting at Central Valley High School

## INFORMATION ABOUT THE DISTRICT

Central Valley School District No. 356 serves nearly 14,000 students in kindergarten through 12th grade in Spokane County. The District has 13 elementary schools, five middle schools, three high schools, three learning centers, and a skills center branch campus.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well approximately 1,800 employees. For fiscal year 2018, the District operated on an annual general fund budget of approximately \$171 million.
