AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Port of Bellingham from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Tenant leases compliance with contract amounts, tracking and monitoring
- Commissioner pay tracking and allowable payments
- Procurement public works, professional services and purchases
- Tracking and monitoring of theft sensitive assets such as cameras, tools, and landscaping equipment
- Self-insurance for health and welfare

INFORMATION ABOUT THE PORT

The Port of Bellingham, located in Whatcom County, provides an array of services including aviation, marinas, marine terminals and property management.

An elected, three-member Board of Commissioners governs the Port. The Board sets policies and appoints the Executive Director to oversee the Port's daily operations as well as approximately 100 regular and up to 15 seasonal employees. In fiscal year 2018, the Port had operating expenses of approximately \$30 million.
