## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of Spokane School District No. 81 from September 1, 2017 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Tracking and monitoring of theft sensitive assets, such as computers, tools, and equipment
- District vehicle usage
- Accounts payable – general disbursements including credit cards and Associated Student Body travel expenditures
- Cash receipting – timeliness and completeness of deposits at Ferris high school
- Student enrollment reporting – Special education
- Financial condition and fiscal sustainability
- Self-insurance for unemployment, and workers compensation

## INFORMATION ABOUT THE DISTRICT

Spokane School District No. 81 serves approximately 30,000 students in kindergarten through 12th grade in Spokane County. The District has 35 elementary schools, six middle schools, seven high schools, a Career and Technical Education (CTE) center and a number of special programs. The District also provides online courses for kindergarten through 12th grade students through Spokane Virtual Learning.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent who is responsible for the daily operations as well as its 3,487 employees. For fiscal year 2018, the District operated on an annual general fund budget of approximately \$419 million.
