AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Authority operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Meydenbauer Center from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Authority's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Software system conversion review – capital assets and payroll
- Payroll – review of commission pay and compliance with employee contracts
- Procurement – compliance with small works roster for public works project

INFORMATION ABOUT THE AUTHORITY

The Bellevue Convention Center Authority, doing business as the Meydenbauer Center, is a public development authority created in December 1989 by the City of Bellevue under state law (RCW 35.21.730) to construct and operate a convention center.

The facility opened for business in 1993. The Authority also manage and operate a destination marketing organization and a Theatre along with the convention center. It is governed by a seven-member Board of Directors, appointed by the City Manager of Bellevue, with the consent of the Bellevue City Council. An Executive Director and three department directors oversee daily operations of the facility, which offers meeting rooms, exhibit space and a 410-seat performing arts theater. The Authority employs approximately 70 full- and up to 140 part-time staff and has an annual operating budget in 2018 of approximately \$21.5 million.
