AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Olympia from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounts receivable – utility billing and collections from City-owned property
- Accounts payable – general disbursements and credit cards
- Cash receipting – timeliness and completeness of deposits at Community Planning & Development and Parks, Arts and Recreation departments
- Equipment rental and replacement – establishment of rates and billing accuracy
- Financial condition and fiscal sustainability
- Open public meeting minutes – documentation of minutes and executive sessions

Financial

Our opinion on the City's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the City's financial statements. That report is available on our website, <http://portal.sao.wa.gov/ReportSearch>.

That report includes a finding for a material weakness in internal controls over financial reporting regarding accounting and financial statement preparation.

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE CITY

The City of Olympia is located in Thurston County and is the county seat and the Washington State Capital. The City provides its 52,490 citizens a full range of municipal services including public safety (police, fire, court and jail), sanitation, utility (water, sewer and stormwater), streets, parks and recreation, arts, community planning and development, zoning and general administrative services.

The City is governed by a council-manager form of government with seven elected Council Members including the Mayor who is elected to position one of the Council. The Council appoints a Manager to oversee the City's daily operations as well as its 568 full-time equivalent employees. In fiscal year 2018, the City operated on a general fund budget of \$94.68 million.
