AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of Bellingham from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance for liability, automotive, vision, worker's compensation and unemployment
- Budget compliance
- Golf course operations contract compliance and controls over receipting, inventory and theft sensitive assets
- Accounts receivable utility billing, adjustments and tax collections
- Finance department receipting timeliness and completeness of deposits, voids and adjustments
- Accounts payable general disbursements, electronic fund transfers and employee reimbursements
- Payroll gross wages, leave balances and accruals, and leave cash outs
- IT security policies, procedures, practices and controls protecting financial systems: IT related policies, backup and recovery, network security and user access
- Procurement cooperative purchases
- Open public meetings documentation of minutes and executive sessions

INFORMATION ABOUT THE CITY

The City of Bellingham encompasses approximately 30 square miles of Whatcom County and serves approximately 88,500 citizens. The City provides an array of services for the City including water, sewer, police, Municipal Court, fire, emergency medical, parks and recreation, library, museum, cemetery, golf course, public improvements, planning and economic development. The City contracts out solid waste collection and disposal.

An elected, seven-member Council and a separately elected Mayor govern the City. The Mayor appoints senior management to oversee the City's daily operations as well as its 905 budgeted employees. In fiscal year 2018, the City had operating general fund expenditures of \$106.1 million.
