## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the Benton-Franklin Health District from January 1, 2017 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounts payable - general disbursements and credit cards
- Compliance with state grants
- Payroll - gross wages
- IT security policies, procedures, practices and controls protecting financial systems - backup and recovery
- Self-Insurance for unemployment compensation

## INFORMATION ABOUT THE DISTRICT

The Benton-Franklin Health District serves approximately 246,000 citizens in Benton and Franklin counties. The District provides environmental health services including food services, worker permits, solid and liquid waste permits, swimming pool testing and public water testing. Personal health services provided by the District include infant immunization, nutrition, education, vital records and disease prevention and detection.

The District operates under a six-member Board. Board membership consists of three Commissioners each from Benton and Franklin Counties. Revenues were \$9,471,048 and \$9,732,167 in 2018 and 2017 respectively. Expenditures were \$9,782,254 and \$9,252,580 in 2018 and 2017 respectively.
