AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Public Charter School operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Spokane International Academy from September 1, 2017 through August 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Public Charter School's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Special education enrollment reporting – review for students eligibility
- Expenditure testing – vendor payments and credit revolving accounts
- Public vs Private accounts – controls over the separation of accounts, testing for completeness
- Cash receipting – review internal controls
- Inventory – controls over tracking of assets
- Open public meetings – documentation of minutes, executive sessions, and expenditure approvals

INFORMATION ABOUT THE PUBLIC CHARTER SCHOOL

Spokane International Academy Charter School, located in Spokane County, provided educational services to approximately 400 students in grades K-3, 5-8 during the 2017-2018 school year.

The Public Charter School is a 501c3 nonprofit corporation established under RCW 28A.710.020 and governed by an eight to 14 member appointed Board of Directors, that establishes policies for the Public Charter School according to the terms of a renewable, five-year charter contract executed under RCW 28A.710.160.

Spokane International Academy is authorized by Spokane Public Schools established by a five-year contract effective July 1, 2016 and terminating June 30, 2021.

The Public Charter School received approximately \$3.7 million in direct state and federal funding for fiscal year 2018. The Public Charter School operates in two buildings and employs approximately 69 employees.
