### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of the City of Moxee from January 1, 2016 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounts receivable billings, adjustments and collections
- Automated controls payroll and utility billings system
- Cash receipting timeliness and completeness of deposits at City Hall and the swimming pool
- Fuel cards monitoring over fuel card usage
- Building permits issuance of permits and cash receipting
- Procurement purchases and public works projects

# INFORMATION ABOUT THE CITY

The City of Moxee serves approximately 3,955 citizens in Yakima County. The City provides services including water, sewer and garbage, a Municipal Court, parks and police services.

An elected, five-member Council and a separately elected Mayor govern the City. The Council appoints management to oversee the City's daily operations as well as its 12 employees. For 2017 and 2018, the City operated on annual budgets of approximately \$8.2 million and \$7.1 million, respectively.
