## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the City of Kenmore from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Self-insurance – compliance with state law for unemployment compensation
- Contracts and agreements – compliance with and proper monitoring of waterfront recreation activities, senior center services, and police services
- Conflict of interest – compliance with state law
- Public Works department – understanding of activity and policies, standby pay, footwear reimbursement pay, small and attractive assets

## INFORMATION ABOUT THE CITY

The City of Kenmore was incorporated on August 31, 1998 and serves 23,320 citizens in King County. The City provides services including administration, engineering, planning, public works, and land use. The Northshore Utility District provides water and sewer services and the Northshore Fire District No. 16 provides fire and emergency medical services. Police services are contracted with King County.

An elected, seven-member Council governs the City. The Council selects one of its members to serve as mayor for a two-year term. The Council also appoints a City Manager to oversee the City's daily operations as well as its 41 employees. For the 2017-2018 biennium, the City operated on a general fund budget of approximately \$23.4 million.
