## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In most of the areas we examined, System operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over safeguarding of public resources.

As referenced above, we noted certain matters that we communicated to System management and Board of Directors in a letter dated November 6, 2019, related to payroll. We appreciate the System's commitment to resolving those matters.

### About the audit

This report contains the results of our independent accountability audit of the Snohomish County Emergency Radio System from January 1, 2017 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the System's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll – leave balances, accruals and cash outs
- Dissolution of entity
- Accounts payable – general accounts payable, credit cards and fuel cards
- Financial condition and fiscal sustainability
- Open public meetings – documentation of minutes, executive sessions and special meetings
