AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the South Whidbey Parks and Recreation District from January 1, 2017 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Tracking and monitoring of theft sensitive assets, such as computers, tools, and equipment
- Payroll – gross wages, overtime, and leave cash outs
- Procurement – purchases and cooperative purchases

INFORMATION ABOUT THE DISTRICT

The South Whidbey Parks and Recreation District was formed in 1986 and provides recreational opportunities for approximately 15,000 citizens. The District has approximately 320 acres of parks and other facilities located in Langley on the south end of Whidbey Island.

An elected, five-member Board of Commissioners governs the District. The Board appoints a Director to oversee the District's daily operations as well as its six full-time employees. The District receives most of its revenue from property taxes and program fees. For fiscal years 2017 and 2018, the District had revenue of \$1,132,783 and \$1,152,699, respectively.
