AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the Port of Whitman County from January 1, 2017 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Payroll Commissioner compensation, payroll increases, 457 deferred compensation plans and match contributions
- IT Software conversion and user access
- Financial condition and fiscal sustainability
- Self-insurance for unemployment

INFORMATION ABOUT THE PORT

The Port of Whitman County was established in 1958 in the city of Colfax. The Port provides industrial and economic development services to the general public. Operations are primarily supported through user charges, such as rent for Port-owned industrial parks and fees for the use of water ports. The Port also operates camping and moorage facilities at Boyer Park and leases telecommunications infrastructure.

An elected, three-member Board of Commissioners governs the Port. The Board appoints an Executive Director to oversee the Port's daily operation as well as its five employees. For fiscal years 2017 and 2018, the Port operated on annual budgets of \$4 million and \$4.1 million, respectively.
