#### **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of the City of Renton from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Third party cash receipting controls and compliance over third party contracts
- Accounts payable general disbursements and credit cards transactions
- Payroll overtime and extra-duty compensation
- Golf course operations controls over operations
- Fuel cards monitoring of fuel use

### INFORMATION ABOUT THE CITY

The City of Renton was incorporated in 1901. It is located on the southern shore of Lake Washington, next to the cities of Tukwila and Kent, and serves approximately 103,000 residents. It operates under the mayor-council form of government.

The City has an independently elected Mayor and seven elected Council Members. The City provides a full range of municipal services including police and court. It operates enterprise funds for water and sewer services and a surface water utility. The City provides parks and recreation, and planning and community development services. It also operates its own airport and golf course. The City's original 2017 general fund operating budget, which provides for the majority of general governmental services, was \$94 million and the final adjusted budget was \$105 million. The City's ending 2017 net position for its governmental and business type activities combined totaled approximately \$933 million.
