AUDIT SUMMARY

Results in brief

Based on the procedures performed, nothing came to our attention in the areas we reviewed that caused us to believe the Response Group was not in substantial compliance with applicable state laws, regulations, and its own policies, or had significant weaknesses in controls over the safeguarding of public resources. Had we performed additional procedures, other matters might have come to our attention that would have been reported.

About the assessment audit

This report contains the results of our independent audit of the Tri-County Hazardous Materials Response Team from January 1, 2017 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives. Local governments are also required by state law (RCW 43.09.230) to prepare and submit certified annual reports to our Office summarizing such things as revenues received, collections made, amounts receivable or payable, expenditures made, and debt owed.

This assessment audit was conducted under the authority of RCW 43.09.260, which requires the State Auditor's Office to examine the financial affairs of all local governments at least once every three years. Assessment audits are risk-based, limited-scope reviews of small local governments, generally defined as local governments with less than \$300,000 in annual revenues. To help minimize audit costs, our work for this engagement was conducted off-site primarily using financial and other information provided by the Response Group.

This assessment audit was limited to the following:

- Reviewing meeting minutes for compliance with the Open Public Meetings Act.
- Inquiring as to internal controls over assets, revenues, and disbursements.
- Verifying that annual reports submitted to our Office were complete and filed timely in compliance with state law.
- Reviewing the Response Group's annual revenues and expenditures for unusual transactions or trends.
- Corroborating financial information reported by the Response Group by comparing its annual revenues, expenditures, and cash and investment balances to third-party sources.

- Reviewing expenditures for indications of unusual activities, excessive Board of Directors compensation, conflicts of interest, or procurement requirements. Based on that review, we compared selected expenditures with supporting invoices and voucher approvals to verify their validity and completeness.
- Evaluating the Response Group's financial information for indications of financial difficulties.

INFORMATION ABOUT THE RESPONSE GROUP

The Tri-County Hazardous Materials Response Group was incorporated on April 17, 1987 and operates under the laws of the state of Washington applicable to non-profit organizations. The Response Group is located in southeastern Washington. The Response Group provides emergency response to hazardous materials incidents.

The governing body of the Response Group is a Board of Directors comprised of one representative from each agency who participates in the Tri-County Hazardous Materials Response Group. Participating agencies include: Benton County Fire Districts 1, 2, and 4, Franklin County Fire District 3, Walla Walla County Fire District 5, Kennewick Fire Department, Pasco Fire Department, Richland Fire Department, Walla Walla Fire Department and Yakima Fire Department. The Board of Directors governs the Team and a Team & Training Coordinator serves as liaison between the 45 Team Members and the Board, as well as coordinates Team activities and training.

The District approximately operated on \$189,000 and \$79,000 in revenues in 2017 and 2018 respectively. The large increase in revenues in 2017 was due to the District receiving a large grant. Most of the revenues come from services that the district provides.
