## **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of Skagit Regional Health from January 1, 2017 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounts receivable patient billing adjustments, pharmacy contract, hospice billings and other miscellaneous receivables
- Accounts payable and procurement online purchases, public works projects and change orders
- Contract compliance cash receipting and deposit timeliness
- Tracking and monitoring of theft sensitive assets computers
- Pharmacy safeguarding of drug inventory
- Creation of Cascadia Care Network, LLC

## INFORMATION ABOUT THE DISTRICT

Skagit County Public Hospital District No. 1, doing business as Skagit Regional Health, currently operates Skagit Valley Hospital, a 137-bed acute care hospital, Cascade Valley Hospital, a 48-bed acute care facility located in Arlington, WA and Skagit Regional Clinics, a multi-specialty Clinic with 18 locations. Skagit Regional Health employed 152 providers in 2017 and 190 providers in 2018, these counts include 30 residents for both years. In addition, the District operates the Cancer Care Center, two Wound Clinics, an ASC and a Physical Therapy Clinic that is located at the Mount Vernon YMCA. Excluding newborns, the District had 37,504 acute care patient days in 2017 and 40,589 acute care patient days in 2018 for both facilities, and a total of 285,036 and 324,214 primary and multi-specialty clinic visits in 2017 and 2018, respectively.

An elected, seven-member Board of Commissioners governs the District. The Board appoints the Chief Executive Officer to oversee the District's daily operations as well as active employees of 2,295 in 2017 and 2,495 in 2018. The District's primary source of operating revenue is from patient services. For 2017 and 2018, the District operated on approximately \$373 million and \$399 million, respectively.
