AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Olympic Medical Center from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages and bonus and incentive payments
- Accounts payable general disbursements, credit cards, travel expenditures and employee reimbursements
- Cash receipting completeness of deposits and cash drawer confirmations at Patient Financial Services
- Procurement public works and prevailing wages
- Self-insurance for unemployment compensation

INFORMATION ABOUT THE DISTRICT

Public Hospital District No. 2 of Clallam County, doing business as Olympic Medical Center, provides health care services to Port Angeles, Sequim and surrounding communities. The District operates Olympic Memorial Hospital, a 126 bed licensed general acute-care facility, and home health services through Olympic Medical Home Health. The District also operates Olympic Medical Imaging Center, Olympic Medical Cancer Center, Olympic Medical Physical Therapy and Rehabilitation, Olympic Medical Laboratory, Olympic Medical Surgical Services, Olympic Medical Cardiac Services and Olympic Medical Physicians, which provides physician clinic services in 13 different specialties across the District.

An elected, seven-member Board of Commissioners governs the District. The Board appoints an Administrator to oversee the District's daily operations as well as its 1,474 employees. For 2018, the District operated on an annual budget of approximately \$199.8 million.
