AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Educational Service District No. 113 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable – credit cards and electronic funds transfers
- General ledger software conversion
- Authority for activities – Olympic Academy
- Self-insurance for unemployment and workers compensation
- Compliance with state grants – Early Childhood Education and Assistance Program
- Payroll – leave cash outs and electronic funds transfers
- Financial condition and fiscal sustainability
- Open public meetings – documentation of minutes and executive sessions

INFORMATION ABOUT THE DISTRICT

Educational Service District No. 113 provides support services to 44 school districts and one state-tribal education compact schools in Grays Harbor, Lewis, Mason, Pacific and Thurston counties and is one of nine such districts in the state. The District provides a wide range of services including fiscal, data processing, risk management, curriculum and instruction, special services and program development.

An elected, seven-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations as well as its 522 employees. For the 2018-2019 fiscal year, the District had an annual operating budget of approximately \$38 million. The majority of the District's funding comes from local, state and federal sources.
