AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Camas School District No. 117 from September 1, 2018 through August 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2019, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Student enrollment reporting
- Payroll – gross wages and leave cash outs
- Associated Student Body activities at Camas High School – fundraisers, gate receipts, inventory
- Use of restricted funds – professional learning
- Accounts payable – electronic funds transfers and credit cards
- Establishment of local revenue and expenditure accounts
- Compliance with public work projects – prevailing wages

INFORMATION ABOUT THE DISTRICT

Camas School District No. 117 provides public school services to approximately 7,217 students in kindergarten through 12th grade in Clark County at three high schools, three middle schools and six elementary schools.

Oversight and fiscal responsibility for the District's operations resides with the elected, five-member Board of Directors. During the 2018-2019 fiscal year, the District's general fund operating budget was approximately \$94 million. The District has approximately 1,020 employees.
